Objection on the following grounds - Within the green belt and holiday type accommodation is not an exception under paragraph 150 of the national planning framework - The limited infill provisions of the NPPF should be interpreted as development of a substantial development frontage and should not include a large backland development such as this - Do the dwellings comply as mobile homes under Section 29 of the Caravan Sites and Control of Development Act 1960? - The plans show each unit has toilet and shower facilities, therefore the need for a permanent toilet building is questionable.
